## Building

- Hosted International Code Council permit technician exam-prep seminar. Three staffers attended and are pursuing certification as the department continues to strive to meet national-level processes, rules and procedures.
- Grace Mackey and police Cmdr. Vic Gualillo continue to work with the City of Jacksonville on 911 emergency response issues pertaining to upcoming Fleet Landing development.

## **City Manager**

- Promoted Scott Williams to the position of Public Works director.
- Conducted interdepartmental new-commissioner orientation with Commissioner-Elect Norris. Additional orientations are scheduled next week.
